

OFFICIAL RULES FOR HILTON GETAWAY GIVEAWAY 2023

NO PURCHASE NECESSARY. VOID WHERE PROHIBITED. Participation constitutes Applicant's full and unconditional agreement to and acceptance of these Official Rules. The 2023 Hilton Getaway Giveaway ("Giveaway") is sponsored by Navy Pier, Inc., 600 East Grand Avenue, Chicago, IL 60611 ("Sponsor"), and starts on August 1, 2023, and ends on September 5, 2023, at 5:00pm CT.

ELIGIBILITY: The Giveaway is open to legal residents of the 48 contiguous United States and the District of Columbia who are eighteen years of age or older. The Giveaway is not open to (a) employees (including members of their immediate families or other persons living in their households) of Sponsor, the Metropolitan Pier and Exposition Authority, Hilton, or any of their respective Board members, officers, subsidiaries, affiliates or advertising/promotional agencies, if applicable; and (b) persons who have won any other prize valued in excess of \$600 in any promotion run by Sponsor or located at Navy Pier in the past twelve (12) months. "Immediate family" means parents, siblings, children, and spouse. All federal, state, and local laws and regulations apply.

HOW TO ENTER: To enter, scan QR code posted on signage throughout Navy Pier. Visit <https://navypier.org/hilton-getaway-giveaway/> and complete entry form no later than September 5, 2023, at 5:00pm CT.

By entering, Sponsor will not make public information related to Participant. Sponsor is not responsible for incorrect, inaccurate, or incomplete entry of information by Participants; lost entries or transmissions, interrupted or unavailable network, server, or other connections; scrambled transmissions or other errors or problems of any kind whether mechanical, human, or electronic, technical malfunctions or the computer hardware, software, or any combination thereof; or problems associated with any virus, or any other damage caused to Participants' systems. No entries by facsimile, overnight courier, or delivery service. One entry per person.

PRIZES: There will be a total of one (1) grand prize winner and five (5) second place winners. A potential Winner may be requested to provide Sponsor with proof that the potential Winner is the authorized account holder. If a dispute cannot be resolved to Sponsor's satisfaction, the entry may be deemed ineligible.
